1. THE LUCY'S WARBLER NESTBOX PROJECT REPORTED 200 YOUNG WARBLERS FLEDGED AS A RESULT OF COMMUNITY MEMBER ENGAGEMENT WITH SCIENTIFIC OBSERVATIONS. TWO PUBLIC SCHOOLS IN TUCSON CONTINUED TO BE A PART OF THIS PROJECT: OCHOA COMMUNITY SCHOOL AND ESCUELA MANZO ELEMENTARY SCHOOL. BETWEEN THE TWO SCHOOLS, 13 CLASSROOMS WERE ENGAGED WITH THE LUCY'S WARBLER NESTBOX PROJECT IN 2018, AND OVER 160 STUDENTS WERE INVOLVED WITH BUILDING AND MONITORING NESTBOXES ON SCHOOL GROUNDS. MORE BROADLY, OVER 200 SOUTHEAST ARIZONA RESIDENTS WERE INVOLVED WITH BUILDING AND MONITORING LUCY'S WARBLER NESTBOXES IN 2018.

TUCSON AUDUBON HOSTED OVER 16,000 VISITORS TO THE PATON CENTER FOR HUMMINGBIRDS IN 2018--THE FIRST CONSTRUCTION-FREE YEAR OF VISITATION SINCE THE COMPLETION OF A CAPITAL PROJECT (BACKYARD VIEWING PAVILION). 2018 VISITATION REPRESENTED AN INCREASE OF APPROXIMATELY 1,500 VISITORS FROM THE PREVIOUS YEAR.
