With regard to the Executive Director or person with substantial influence over the Organization, the Board shall follow procedures set forth in Article V of the conflict-of-interest policy in order to decide whether or not to enter into the transaction and, if so, to ensure the terms of the transaction are reasonable. In the case of a director, if it is determined that a conflict of interest exists, the director shall leave the meeting while the transaction is discussed and shall not vote on it. The remaining directors shall follow the procedures set forth in Article V of the conflict-of-interest policy in order to decide whether or not to enter into the transaction and, if so, to ensure the terms of the transaction are reasonable. Deliberations and decisions are recorded in the board minutes.
